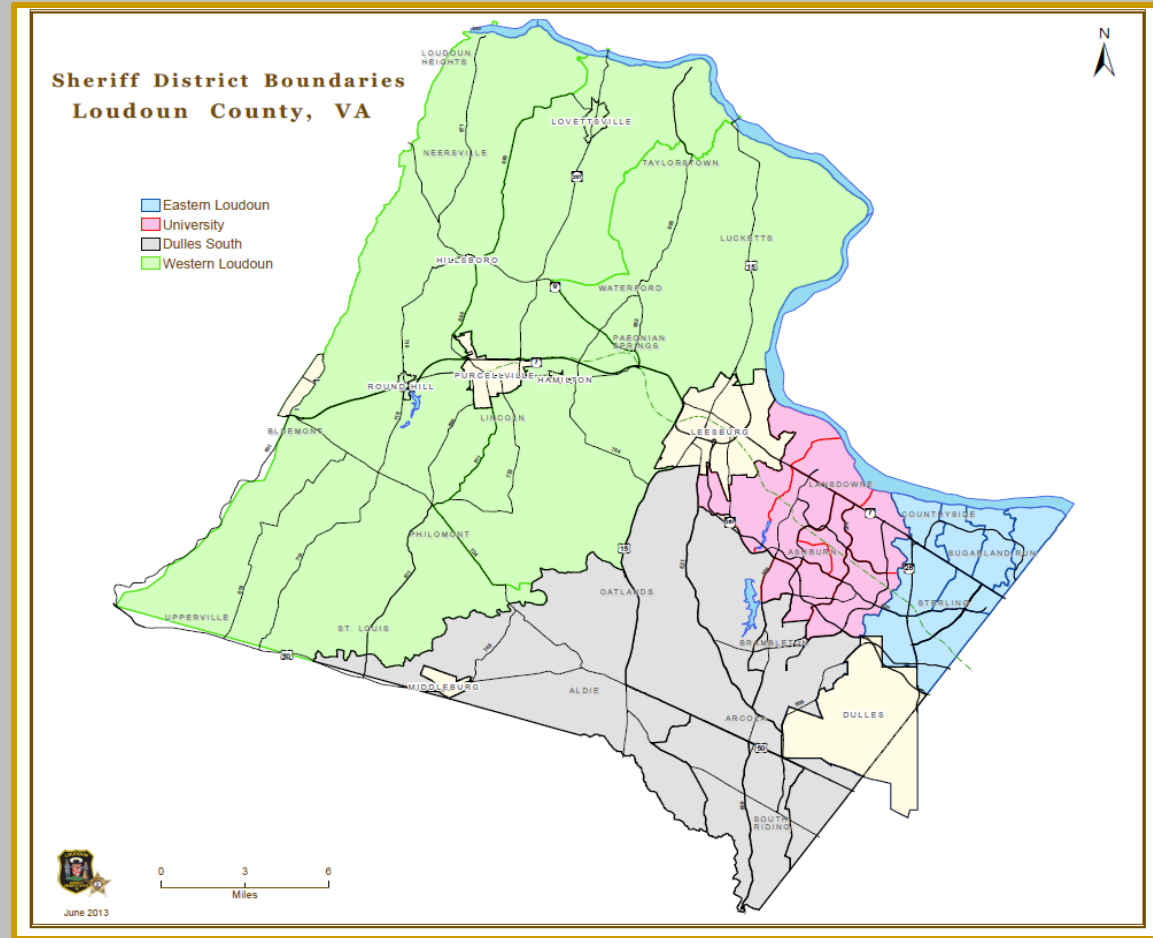

**NON-ACCEPTABLE ITEMS:** Needles, Thermometers, Batteries, IV Bags, Blood or Infectious Waste, Liquids, Gels or Sprays.
