Virginia Department of Health Launches Text Messaging Service to Streamline Positive Test Result Awareness and Exposure Notifications

The message will contain a link and a code to allow the message recipient to anonymously submit the test result through [COVIDWISE](#), Virginia's free COVID-19 Exposure Notifications app, to share with others who may have been exposed. VDH says the new service is intended to streamline the process for positive test result awareness and exposure notifications.

The Virginia Department of Health has launched a new service that will send texts to people who test positive for COVID-19.

This new text messaging service will be used to alert anyone with a registered valid mobile phone number of a positive

Supplemental Real Estate and Personal Property Tax Deadline is February 5, 2021

Loudoun County Treasurer H. Roger Zurn Jr. reminds taxpayers that the deadline for payment of supplemental real estate and personal property taxes is Friday, February 5, 2021.

Payments received or postmarked after February 5, 2021, will incur a 10% late payment penalty. Additional interest at the rate of 10% per annum will be assessed. In addition to the late payment penalty for personal property taxes, if the taxes remain unpaid for 60 days after the original payment due date, the taxpayer will incur an additional 15% penalty of the total amount due. The due date will not be extended for bills where assessment questions have been filed with the Board of Equalization.

Local Student Seeks Loudoun Opinions on Confederate Monuments



A current student at Potomac Falls High School who reached out to my office for assistance with a capstone project for her Advanced Placement (AP) Research class.

She is conducting a survey for authentic research and data on the controversy around Confederate monuments, both locally and in other places such as Richmond and Charlottesville, Virginia. She has narrowed the scope of her survey to Loudoun County citizens' stances and opinions regarding the display of Confederate monuments on public lands

and how it affects different individuals.

In an effort to help a local student increase participation in her survey, we hope that you will consider submitting a response, no matter the opinion. The survey is open to all Loudoun residents and all responses are confidential and anonymous.

Survey responses will be collected through March 1, 2021.

At the end of the academic year, she will submit a 4,000-6,000 word research paper on her findings, as well as deliver a 15-20 minute oral presentation.

Loudoun to Host Free Twice-Weekly COVID-19 Testing

Loudoun County will hold twice-weekly, free drive-thru COVID-19 testing events at multiple locations beginning in February. Unlike past testing events hosted by Loudoun County, these weekly, fixed events will not be mass testing sites and instead are intended to provide regular, predictable testing opportunities for the community. As a result, capacity at these fixed testing sites will be limited.

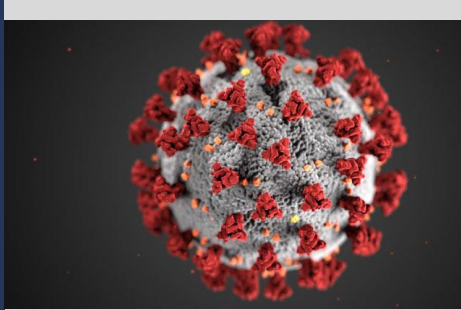
