TODAY: June 8th Gubernatorial Primary Election; Polls Open Until 7:00 pm



Today is the day! All precincts in Loudoun County will have a Democratic Party Primary only, the Republican Party have administered their own process to select candidates.

Six Things to Know about the June 8, 2021, Primary Election in Loudoun

1. Know When to Vote

Polls in Loudoun County will be open from 6:00 a.m. to 7:00 p.m., Tuesday, June 8, 2021.

2. Know Where to Vote

Most voters will cast their ballots at their normal polling location. However, there are two precincts where voters will use the same alternate locations as they did in November 2020. [Look up your polling place.](#)

3. Know the Rules About Identification

Voters will be asked to show an [acceptable form of identification](#), such as a Virginia DMV-issued driver's license.

- Voters who do not have an acceptable form of ID can sign an ID statement affirming their identity and they will be able to vote a regular ballot.

4. Know Who is on the Ballot

Offices on the ballot will include Democratic Party nominees for governor, lieutenant governor, attorney general, and members of the House of Delegates in Districts 34 and 86. [View a sample ballot.](#)

5. Know Who Can Vote

All registered voters in Loudoun County are eligible to vote in the primary election as Virginia does not register by party affiliation.

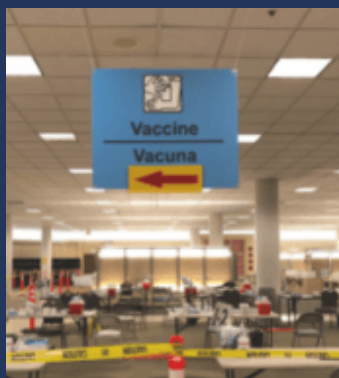

Walk-in Service Now Available at Loudoun COVID-19 Vaccination Clinic

Loudoun County is now offering walk-in service at the COVID-19 vaccination clinic, which is located at Dulles Town Center, 21090 Dulles Town Circle in Sterling. Individuals 12 years and older are eligible for vaccination on a first-come, first-served basis.

Appointments for COVID-19 vaccine are also still available. Appointments can be scheduled anytime online.

The hours of operation for the county's COVID-19 vaccination clinic will adjust throughout June to accommodate walk-in services and demand for service to ensure the clinic is operating at maximum efficiency while serving the community. Beginning June 14, the clinic will operate three days per week with abbreviated hours. The hours of operation will adjust on June 14, June 21, and on June 23.

COVID-19 Funeral Assistance Update

The Federal Emergency Management Agency reports that it has dispersed more than \$128 million to nearly 19,000 people who applied for financial assistance for funeral expenses incurred after January 20, 2020, for deaths related to COVID-19. The program began accepting applications in April. So far in Virginia, 350 applicants have received assistance totaling more than \$2 million.

To be eligible for funeral assistance, applicants must meet these conditions:

- The death must have occurred in the United States. The applicant must be a U.S. citizen, non-citizen national or qualified alien who incurred funeral expenses after January 20, 2020.
- The death certificate must indicate the death was attributed to COVID-19.
- There is no requirement for the deceased person to have been a U.S. citizen, non-citizen national or qualified alien.

REMINDER: Shuttle Service is Available at the Loudoun Vaccine Clinic



Loudoun County continues to offer a free shuttle service between the Loudoun County Transit bus stop at Dulles Town Center and the county's vaccination site located at the other end of the shopping mall. The shuttle runs continuously during the vaccination site's hours of operation. Anyone who has an appointment

scheduled at the Health Department's vaccination clinic and arrives via Loudoun County Transit is encouraged to ride the shuttle.

The shuttle, operated by the Department of Parks, Recreation and Community Services, is running continuously from 9:00 a.m. to 5:00 p.m. each day the vaccination site is open. Anyone who has an appointment scheduled at the Health Department's vaccination clinic and arrives via Loudoun County Transit is encouraged to ride the shuttle.

To get to the vaccination site on a [Loudoun County Transit Local Bus](#), riders may choose from Routes 62, 70, 81, 82 or 84, which serve the Dulles Town Center. Fares for the local bus are \$1 each way.

The shuttle service will help eliminate mobility barriers to vaccination for people who rely on public transportation and may have difficulty walking long distances.

Loudoun County Schedules Free COVID-19 Testing Events through June

Loudoun County will continue to hold free, drive thru COVID-19 testing events through June.

The events are scheduled for **Tuesdays, 10:00 a.m. – 1:00 p.m.**, at the following locations:

- **June 15:** Philip A. Bolen Memorial Park, 42405 Claudia Drive, Leesburg (Enter the park on Crosstrail Boulevard from Sycolin Road.)
- **June 22:** Cascades Library, 21030 Whitfield Place, Potomac Falls (Access the testing location in the back parking lot, near the senior center.)
- **June 29:** Dulles South Recreation & Community Center, 24950 Riding Center Drive, South Riding

The testing events are free and open to all. There are no age or residency requirements. No prescriptions or appointments are necessary. A person does not have to exhibit symptoms of COVID-19 to be tested. A PCR test (nasal swab) will be administered, which tests for the novel coronavirus. No antibody or rapid tests will be offered. **No COVID-19 vaccine will be available at these events.**

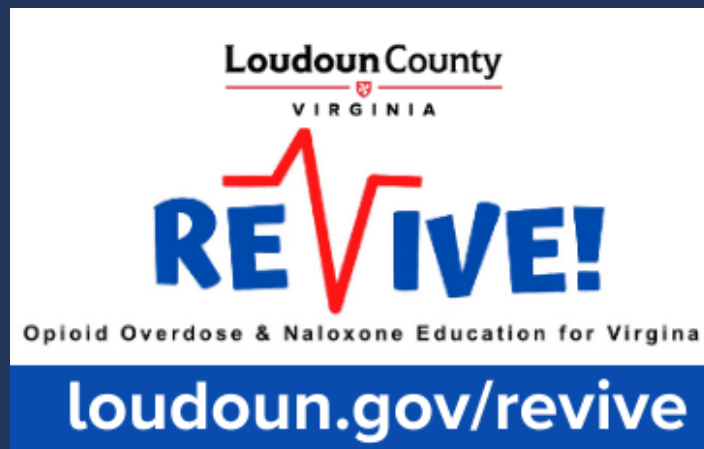

Learn How to Reverse an Opioid Overdose June 10 or June 14



Space is available in an upcoming Revive! class, Loudoun County's virtual opioid overdose reversal training.

"REVIVE!" is the Opioid Overdose and Naloxone Education program for the Commonwealth of Virginia. the Loudoun County Department of Mental Health, Substance Abuse

and Developmental Services (MHSADS), the Loudoun County Community Services Board and the Virginia Department of Health sponsor the local training sessions.

Anyone who uses opioids or knows someone who does is encouraged to take the class to learn how to recognize and respond to an opioid overdose.

SCAM ALERT: Important Update from LCSO

GOVERNMENT / LAW ENFORCEMENT SCAM

if you receive a call from someone reporting to be from a government or law enforcement agency and are asked to provide personal information such as bank account, social security, account login information, etc. OR to purchase gift cards to avoid legal action or to satisfy a warrant -

NEVER provide banking or personal account information. Agencies will not ask you to purchase gift cards, wire money, or transfer money through a cash app (such as Venmo, Bitcoin, PayPal, or Zelle.



The Loudoun County Sheriff's Office is currently receiving reports of fraudulent telephone scams involving persons claiming to be with the Loudoun County Sheriff's Office.

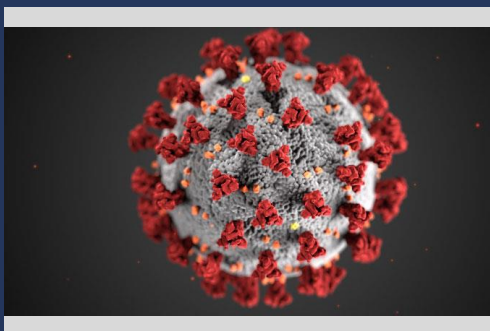
The caller claims to be a Lieutenant Daniels with the agency and says you missed a court date. He further claims there is a warrant for

your arrest. The scammer then advises you can turn yourself in or resolve the issue by paying a fine. He refers you to a records clerk named Alexis.

Remember- under no circumstance would a law enforcement official in Virginia be permitted to collect fines of this nature.

If you receive a call from someone claiming to be with a law enforcement agency or government entity claiming that you missed court, have a warrant, are past due on a bill, etc. and they ask you to purchase gift cards or cash app money - it is a scam.

The county continues to encourage everyone in the community to take steps to limit the spread of COVID-19, which include:

- Wear a mask/face covering ([see requirements](#))
- Wash your hands often with soap and water for at least 20 seconds. Use an alcohol-based hand sanitizer only if soap and water are not available.
- Avoid touching your eyes, nose and mouth.
- Cover your mouth and nose with a tissue or your sleeve (not your hands) when coughing or sneezing.
- Clean and disinfect frequently touched objects and surfaces.
