Mr. Inniger is a well-known businessman throughout the county and frequents the ELS service area. He specializes in commercial property management and snow removal.

On December 9, 2013 while working in the recent Severe Weather Storm he was involved in a serious accident on Route 50 involving a 3.5' in diameter tree. While traveling on Route 50 he could see the branches of a tree falling in front of him. He swerved to avoid them and ended up skidding 20 feet over an embankment and off the roadway. 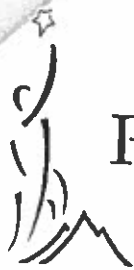
