As you are aware, the Sheriff's Office was recently confronted with the potential threat of a communicable disease as a result of an arrest at Dulles Airport. Following the inmate's confinement at the Adult Detention Center, decisions had to be made with respect to potential transmission to inmates and employees at the Adult Detention Center as well as the Judges, staff and the public in the Courthouse.

I am writing to thank you and your staff and to commend everyone involved for their prompt and professional response to this potential threat. In particular, the Judges were briefed by Regional Vice President of Operations for Correct Care Solutions Jim Sokoi, Captain Ebersole, Lieutenant Cox, Lieutenant McCartney and Sergeant Foscatto. With the information that we received and with their assistance we were able to develop a rational response that allowed us to continue to afford access to the judicial system and at the same time afford protection to the public and staff in the Courthouse. All of the Judges are grateful for the collaborative efforts of the Sheriff's Department. I feel confident that we can continue to work cooperatively in the future.

Dear Sheriff Chapman,

I wanted to share with you our family's appreciation to Deputy Russell.
On August 30th morning we were busy preparing to leave to take our almost three year old son to a train ride at Walkersville, MD.

With car running (started with remote start) and my keys inside the car, the only door left open closed with my son left inside by himself and he was already strapped into the car seat. This had occurred because our drive way is on a steep incline and a slightest wind or movement closes the door. My wife's key was already in the car in her backpack so we had no way to open the door. (I began backing in my car since this day so it never happens again)

In panic I called the Loudoun Sheriff's non-emergency line and explained the situation. An ambulance with three personnel arrived within few minutes, followed by Deputy Russell.

After the personnel from the ambulance were unable to open the door with a door hook, they began getting ready to break one of the windows. I had been afraid that this may scare my son even more so it was the least favorable option but it seemed like we had no other choice.

This is when Deputy Russell stepped and attempted to open the front door handle using the tools the ambulance personnel had brought - and amazingly within a few minutes he had the door opened and our son was safe.

Luckily it had not been too hot that day and our son was fine - and he does not seem to experience any lingering fear of getting into the car again - which I was afraid may have happened if we had broken a window to get him out.

I realize there may be other Deputy Russell's within the force - below is my information if it helps in identifying the specific Deputy that helped us that day.

Thank you to Deputy Russell, and to you for running such a professional courteous, and helpful Sheriff's office.
