COMMENDATION LETTER

Dear Sheriff Chapman:

This letter commends Deputy Nyce for his response to our concerns regarding juvenile loitering and littering on community property in the Mirror Ridge subdivision.

On Friday, 1 September, we called the Sheriff's Office about what appeared to be day and night "camping" activity in the woods between [REDACTED] [REDACTED]. Over the past several months, we observed young adults trespassing in that area and smoke emanating from the campsite. We were concerned about such trespassing since the site was littered with trash, bottles, food containers, cigarette lighters, cigar wrappers, a broken chair and a backpack containing a laptop.

Deputy Nyce responded to our call in short time and personally inspected the site while commenting on the probable ages of the trespassers and noted evidence of drug (marijuana) paraphernalia. He mentioned similar activity at an abandoned home site between the Mirror Ridge and Sugarland Run subdivisions, which was under the Sheriff's Office surveillance. He also advised us that our community was experiencing frequent burglary of unlocked automobiles.

Deputy Nyce took possession of the backpack and laptop with the intent of tracking ownership as possible stolen property. He left his business card advising us to call him in the event the trespassers were present, so that he could observe the juveniles first hand. He also stated that the campsite would be placed on the Sheriff's "watch list." Later in the process of cleaning up the campsite, we found another backpack and notified Deputy Nyce via email. He immediately responded and took possession of the bag as further evidence, noting the contents and assessing disposition of ownership.

In summary, we could not have been more pleased with the response of the Sheriff's Office and, in particular, the character, department and diligence of Deputy Nyce. As Loudoun citizens, we fully appreciate his dedicated service to ensure a safe and peaceful community. Without question, he is a credit to the Loudoun County Sheriff's Office.

Dear Sheriff Chapman,

Thank you to the men and women of the Loudoun County Sheriff's Office! They do a great job day in and day out keeping us safe. I am writing to commend, in particular, Deputy P. T. Pao for his handling of a complex situation which ultimately turned out to encompass both criminal and civil issues. By way of introduction, I am a retired senior executive level federal law enforcement officer, with experience ranging from the working street level through the senior supervisory levels of federal law enforcement. While I am writing to you in my capacity as a private citizen of Loudoun County, my four decades in our profession cannot but help influence my observations.

I will spare you the details which I'm sure can be found in the deputy's report, but suffice to say he responded to what he thought was a domestic (child custody) call. At some point it became apparent to Deputy Pao that he had something much more complex on his hands.

Leaving the substance of the ensuing potential criminal matter aside, the point of this letter is to remark at how impressed I was with Deputy Pao's interview skill, demeanor, and mental agility. Briefly stated, my daughter's ex-husband had been invited to her house to visit their child, my granddaughter. Apparently, the ex-husband's behavior in the vicinity of his vehicle shortly after arriving raised concerns among some neighbors. Facing a situation which required him to interact with a worried mother, her concerned father (me), and my daughter's ex-husband, Deputy Pao took control of the situation while ensuring officer and civilian safety in a level-headed, clearly articulated manner. He and his partner calmly resolved the domestic call, and as we would later learn, he also had skillfully obtained evidence of what ultimately turned out to be a serious criminal matter involving the ex-husband. The ex-husband has subsequently been convicted in Loudoun County Circuit Court of a drug distribution offense.

Based on my observation and interaction with Deputy Pao and formerly having supervised a world-wide investigative program among other duties, I believe that Deputy Pao has the requisite skills and demeanor to be an outstanding investigator/detective. We are fortunate to have him serving us in Loudoun County! Thanks for reading this letter.
