Without him pulling me over, I could have been in an accident if someone did not see my vehicle. Officer Atchison was very clear with me as to why he pulled me over and what the problem with my vehicle was, he stated that it was hard for him to see my vehicle in the dark and informed me of the importance of having a repair made. He issued me a warning, which I do appreciate.

Next up, last Sunday the 29th, I called in a report of a running vehicle blaring music at 06:30 to your non-emergency number. Your operator, whose name I unfortunately have forgotten was very nice and easy to understand, even in my very drowsy state. Shortly after I spoke to the operator, I laid back down, then heard music cut, I looked out my window surprised to see several cruisers and officers speaking with the driver. I checked the Daily Crime Report to find my incident at the very top. I wanted to again call out your officers for taking care of this issue. I initially thought about approaching the vehicle myself, but I am very glad that I called as I saw in the Report that the person was charged with Public Intoxication and intoxicated people have a higher probability of getting violent.

I have lived in various jurisdictions in Virginia and my favorite thus far is Loudoun. I know you all work very hard for your residents.
