Wanted to follow up on our discussion yesterday, in front of the Purcellville dry cleaners.

Wanted to make you aware that Deputy Solan did a terrific job working with my 16 year old daughter.

On her the way to Woodgrove High School, my daughter was driving our Ford Excursion and hit mirrors with another truck on one of the dirt roads leading to the school. It occurred at the top of a hill where both drivers stopped on the downward side and unable to see the other. As a result, the other driver assumed she just kept going and reported a hit and run which Deputy Solan was called to investigate.

Deputy Solan called me and asked if he could talk to her at school, which he did. When my daughter got home I ask her how it went and her comments where "He was very nice to me. He even ask me about my cows"

As my daughter continued to tell her story it was obvious that Deputy Solan provided her guidance on several items:

1. what to do next time there was an accident ..... she didn't realize that hitting mirrors would be considered an accident
2. when an officer ask for your drivers license, don't hand the officer your whole wallet
3. insurance cards are typically located in the glove box vs. center console

This week she attended her licensing ceremony and it was good to hear the officer at the ceremony iterate the same.

Pulling my daughter out of class and questioning her about the accident could have been a scary situation for her but Deputy Solan turned it into a learning experience. I'm confident this wasn't a one-off but rather the way Deputy Solan carries himself and represents the Sheriffs Department.
