# **2007 Survey of Loudoun Residents Executive Summary**

The Loudoun County government conducted a telephone survey of 1,000 Loudoun County residents in November 2007 to update demographic information and obtain residents' opinions concerning key issues. The county has conducted similar surveys approximately every two years since 1995.

## **Methodological Changes**

The county was divided into two areas, rural and non-rural, for the 2007 survey. The survey solicited responses from a stratified random sample of 250 households in the rural areas and 750 households in non-rural areas, totaling 1,000 Loudoun County residents overall.

In prior surveys the county was divided into three areas – east, central, and west – for the purposes of determining the sample and analyzing the results. The large population growth that Loudoun County experienced over the past several years has changed the demographics of the county and caused a westward expansion of the population. As a result of the changing demographic landscape, the survey's geographic areas were changed to best represent the distinct geographic areas within the county today.

Improvements to the surveying and statistical method were made for this latest survey. Geographic weighting was used to generalize results to the entire county and within the rural and non-rural areas so that one zip code's population was not over- or under-represented. To afford the opportunity to analyze changes over time for a few specific variables, 2002 and 2005 results were adjusted using the same statistical methods used for the 2007 survey. Details on the new methodology can be found in Appendix F.

#### **New Questions in 2007**

The 2007 survey included the following new questions:

- Do you intend to stay in Loudoun County after you retire? If not, what would be your reason for leaving?
- Are there sufficient nighttime activities in Loudoun County for members of your household? What nighttime activities are missing?
- If you have used or searched for child care here, please tell me how satisfied you are with child care options in Loudoun County.
- If dissatisfied with child care options in Loudoun County, why are you dissatisfied?

Additional options were also added to some of the questions to reflect the changing demographics and to represent key issues that were believed to be of concern to residents.

## **Removed Questions in 2007**

The U.S. Census Bureau is now conducting the annual American Community Survey (ACS). Compared to the Loudoun Survey of Residents, the ACS sample size is much larger, which gives a higher degree of accuracy. Three questions that are asked in the American Community Survey were therefore, removed from the 2007 Survey of Loudoun Residents. The following questions were removed:

- Is English the primary language spoken in your home?
- What is the primary language spoken in your home?
- Do you rent or own your home?

### **Demographics**

Residents indicated that Loudoun's demographic profile is still changing. Loudoun County is becoming more ethnically diverse and more affluent, the county has a high percentage of households with children, and a greater percentage of residents have resided in Loudoun for greater lengths of time.

- Over half of Loudoun County households surveyed 54 percent reported an annual household income above \$100,000. The 2002 and 2005 surveys had 43 percent and 48 percent of households reporting incomes above \$100,000, respectively.
- Children ages 18 and under totaled 33 percent of residents.
- The length of tenure of residents is increasing. Eighteen percent of residents surveyed have lived in Loudoun for three years or less, which is a downward trend from 2002 and 2005 when it was 34 and 27 percent respectively. Forty-four percent have lived in Loudoun for more than ten years, compared to 33 and 36 percent in 2002 and 2005.
- 93 percent of residents indicated that they moved to Loudoun from somewhere else. The largest percentage of new Loudoun residents relocated from Fairfax County (40 percent), followed closely by residents moving to Loudoun from outside the Washington, D.C. area (38 percent).
- Residents indicated that their major reason for relocating to Loudoun was location of work site (28 percent), followed by housing affordability (25 percent) and family considerations (13 percent).
- Asked if they intended to stay in Loudoun County after retiring, 35 percent of respondents said yes, 34 percent said no, and 31 percent were unsure. Of those residents who said that they would not stay in Loudoun, the top reason sited for not staying in Loudoun County was affordability of housing (35 percent).

## **Employment**

Of the surveyed households and residents:

- Of 1,553 employees in households, 43 percent worked in Loudoun County. Members of households employed in Fairfax County comprised 35 percent of all workers.
- 24 percent of residents indicated that someone in their household telecommutes. This is up from 19 percent in 2005. Approximately half of residents who telecommute sited transportation as the biggest issue facing the county.

## **Usage and Satisfaction with Selected County Services**

Of the surveyed residents:

- 89 percent indicated that someone in their household had used at least one of the designated services during the past two years.
- 96 percent reported satisfaction with fire and rescue services.
- 95 percent expressed satisfaction with public libraries.
- 95 percent were satisfied with parks and recreation facilities.
- 92 percent reported satisfaction with the public schools.

## **Opinions about Key Issues**

Of the surveyed residents:

- Of those residents who had moved to Loudoun County, 96 percent felt very safe or safe in Loudoun County compared to their previous locality.
- Of the lifelong residents, 94 percent felt very safe or safe in their current neighborhood.
- 92 percent rated Loudoun's quality of life as good or excellent.
- 75 percent said that Loudoun County provides good value for the tax dollar.
- In 2007, 2005, and 2002, transportation and growth/development have been cited as the top two issues facing Loudoun County. In 2007 transportation (47 percent) was cited as the top issue and growth/development (40 percent) was the second biggest issue. In 2005 and 2002, growth/development had a greater percent than transportation.
- In 2007 (22 percent) and in 2005 (25 percent) of residents felt that the single best thing about Loudoun was its location and proximity to shopping, activities, jobs and other amenities.
- The second leading choice identified as the single best thing about Loudoun was the rural countryside and open space, with 20 percent in 2007 and 22 percent in 2005.
- 60 percent of residents said that Loudoun County had a sufficient amount of nighttime activities for members of their household.

#### **Information Sources and Internet Access**

Surveyed households were asked how they receive information about county programs and services. The survey also asked if they have access to the Internet in their home and what type of connection they have.

- 85 percent of residents indicated that they receive information on county programs and services through newspapers. The top newspapers named were the *Loudoun Times-Mirror* (43 percent), *Loudoun Easterner* (30 percent), *The Washington Post* (29 percent), and *Leesburg Today* (28 percent).
- 92 percent of households reported having access to the Internet in their home. The number one means for access was cable broadband service with 30 percent. Fiber optic cable ranked second with 26 percent and DSL ranked third, with 20 percent of households using it to access the Internet.

## Section I. Introduction

## **Purpose and Scope**

In November 2007, the County Administrator commissioned a telephone survey of a random sample of 1,000 households in Loudoun County. There were several principal purposes for conducting a scientific survey of Loudoun County residents at that time:

- To update key demographic characteristics of Loudoun County residents that were obtained in similar surveys conducted approximately every two years since 1995;
- To find out critical information about the users of specific county services and their satisfaction with those services; and
- To provide the Board of Supervisors with additional input from residents regarding key issues and programs as it addresses strategic initiatives and plans for Loudoun County.

## Methodology

The 2007 Survey of Loudoun Residents was designed to be a telephone survey, approximately five to ten minutes in duration, that would provide useful demographic information and obtain residents' opinions concerning key issues. The county retained a marketing research firm, Decision Data Collection, Inc., to conduct the telephone survey of Loudoun households.

The survey instrument, modeled on previous Loudoun County surveys, was modified slightly to reflect current information needs and was further reviewed by Decision Data Collection's statistical experts. Upon completion of the survey, Decision Data Collection provided the data and tabulations directly to Loudoun County for analysis.

As in prior surveys, the geographic areas into which the county is divided are based on an aggregation of zip codes. Groupings of zip codes are preferred because virtually all respondents know which zip code they live in and virtually all are willing to give their zip code during the interviewing process.

The county was divided into two areas, rural and non-rural, for the 2007 survey. The geographic boundaries of these two areas are depicted on the map found at the end of this section. In past surveys, the county was divided into three areas, east, central, and west. The large population growth that Loudoun County has experienced over the past several years has changed the demographics of the county and created a westward expansion of the population. The population growth in the central and eastern areas has caused these two areas to merge together geographically and demographically.

Therefore, the central and eastern areas are now represented as one area, the non-rural area. In prior surveys, the Aldie (20105) and Arcola (20107) zip codes were included in the western area. The Aldie zip code area has experienced a large amount of population growth east of Route 15, and the majority of its population is now east of 15. All zip codes that are completely east of Route 15 or have portions east of Route 15 are included in the non-rural area. Therefore, the Aldie and Arcola zip codes are now considered to be part of the non-rural area.

The survey solicited responses from a stratified random sample of 250 households in the rural areas and 750 households in non-rural areas, totaling 1,000 Loudoun County residents overall. There were an estimated 95,666 households in Loudoun County in 2007. The survey sample represents approximately 1.05 percent of all households in Loudoun County.

The rural area of the county has a relatively small number of households. There are 13,219 households in the rural area, representing 13.8% of the county's households. As in prior surveys, the rural area was over-sampled in order to provide more statistically reliable results and a more detailed look at the demographics and opinions of the residents of that area of the county. Countywide, the data is within +/- 3.1 percent at the 95 percent confidence level. The rural area's data is within +/- 6.1 percent at the 95 percent confidence level. The non-rural area's data is within +/- 3.6 percent at the 95 percent confidence level.

Geographic weighting was used to generalize results to the entire county and within the rural and non-rural areas so that one zip code's population was not over- or under-represented. To afford the opportunity to analyze changes over time for a few specific variables, 2002 and 2005 results were adjusted using the same statistical methods and geographies used for the 2007 survey. Further details on the weighting methodology can be found in Appendix F.

Decision Data Collection was able to achieve a fairly high cooperation level of 63.7 percent from Loudoun residents. This indicates a relatively strong willingness on the part of Loudoun County citizens to communicate with the county government and Board of Supervisors about important issues.

A Spanish language survey option was available beginning in 2005 for those who requested it, and that option was also available for the 2007 survey. In 2007, nine people (less than one percent of the total) requested and completed the survey in Spanish.


## **Report Organization**

The focus of this report is to summarize key responses about county services and to highlight important information that may be helpful to the Board of Supervisors in policy and budget development.

The report is divided into five sections that reflect the key purposes of the survey.

• Section I introduces the report and discusses the background and methodology.

- Section II provides a brief overview of key demographic characteristics of the survey respondents, and the ways in which they receive information about county programs and services. This section also discusses household access to the Internet.
- Usage patterns and satisfaction levels for each of the designated services are discussed in Section III.
- Section IV summarizes general opinions regarding how residents feel about Loudoun.
- Conclusions drawn from the survey are discussed in Section V.
- A copy of the complete survey instrument is provided in Appendix A.
- Tables showing the 2007, 2005, and 2002 weighted sample results for key questions are provided in Appendices B, C, and D.
- Appendix E provides a comparison of responses to key questions from the 2007, 2005, and 2002 surveys.
- Appendix F describes the sampling and statistical methodology used to derive the survey results.



# Section II. Demographic Characteristics of Residents

For certain key demographic variables, such as household characteristics, racial composition and mobility, the most current and reliable source of data available is the U.S. Census Bureau's 2006 Time Series Estimates and American Community Survey. For total housing units, households, and population, the most current and reliable source of data is produced by the Loudoun County Demographer in the Department of Management and Financial Services.

In 2000, the county's population was 169,599, according to the U.S. Census Bureau, and in 2007 it was 271,069, according to the Department of Management and Financial Services. In 2000, the county's household total was 59,900, according to the U.S. Census Bureau, and in 2007 it was 95,666, according to the Department of Management and Financial Services. This is a population increase of 60 percent and household increase of 60 percent from 2000 to 2007.

Survey research provides an opportunity to collect other demographic information for comparison with historic trends and for benchmarking with projections. Many of the demographic questions in the survey were also asked in the biennial Surveys of Loudoun Residents that were conducted between 1995 and 2005.

The 2007 survey was the first Survey of Loudoun Residents to use the geographic weighting technique. To afford the opportunity to analyze changes over time for a few specific variables and to assess the reliability of survey responses, 2002 and 2005 results were adjusted using the same statistical methods used for the 2007 survey. The 1995, 1997, 1999, and 2001 survey results were not adjusted, hence they are not directly comparable to the 2007 results. The U.S. Census Bureau's Census 2000 and American Community Survey also provides an opportunity to analyze the demographic trends and to assess the reliability of survey responses.

#### **Location of Residents**

The survey solicited responses from 1,000 Loudoun County households. Of those 1,000 households, 750 were in the non-rural area zip codes of Aldie, Arcola, Ashburn, Chantilly, Great Falls, Herndon, Leesburg, and Sterling. The other 250 households were in the western, rural area zip codes of Bluemont, Hamilton, Lovettsville, Middleburg, Paeonian Springs, Paris, Purcellville, Round Hill, Upperville, and Waterford.

#### **Household Characteristics**

The average size of surveyed households equaled 3.15 persons per household in 2007 and it has increased over time. In 2002 it was 2.99 and in 2005 it was 3.10.

Of the total number of persons in households surveyed, 9 percent were children ages 4 or younger, 17 percent were children ages 5 to 13, and 8 percent were children ages 14 to 18. Children ages 18 and under totaled 33 percent of residents.

These survey results are indications of the large number of family households in Loudoun County. Loudoun County has one of the highest percentages of family households in the United States according to the U.S. Census Bureau.

## **Racial/Ethnic Characteristics**

Loudoun's population has diversified with time. In 2007, 77.3 percent of surveyed respondents were white. This is a decrease from 2002 (86.4 percent) and 2005 (83.9 percent). The black population increased slightly among surveys, to 5.9 percent in 2007, compared to 5.5 and 5.8 percent in 2002 and 2005 respectively. The 2007 Asian population (8.7 percent) is similar to the 2005 figure of 8.9 percent, but an increase from 2002 (6.9 percent). In 2007 the Hispanic population (5.6 percent) was the same as in 2005, but increased from 2002 (3.2 percent).

#### Income

Households with incomes above \$100,000 comprised over half of Loudoun County households surveyed – 54 percent. This included households with an annual household income between \$100,001 and \$150,000 (28 percent) and those with an annual household income over \$150,000 (26 percent). Another 19 percent reported a household income between \$75,000 and \$100,000. Household incomes above \$100,000 have been increasing sharply since 2002. The 2002 and 2005 surveys had 43 percent and 48 percent of households reporting incomes above \$100,000, respectively. The pricing of housing, high wage jobs in the region, and rapid population growth are the key factors contributing to the rapid increase in household incomes in Loudoun County.

## **Housing Characteristics**

The type of housing that residents live in has remained relatively similar from 2002 to 2007. Sixty-four percent of households surveyed lived in single-family detached housing, 23 percent lived in townhomes or duplex units, 11 percent lived in multi-family units, and one percent reported living in some other type of unit.

## **Length of Residence**

Residents living in Loudoun for three years or less comprise 18 percent of all residents, which is a downward trend from 2002 and 2005 when it was 34 and 27 percent respectively. Thirty-nine percent have lived in Loudoun for four to ten years, which is an upward trend from 2002 and 2005 when it was 33 and 37 percent respectively. Forty-four percent have lived in Loudoun for more than ten years, compared to 33 and 36 percent in 2002 and 2005. These survey results signify that people are staying in Loudoun County longer, and reflect residents' perceptions of the county's high quality of life.

Rural residents have longer tenures in Loudoun County than non-rural residents, with 59 percent of rural residents having lived in Loudoun for more than 10 years compared to 39 percent of non-rural residents. These results are generally consistent with past survey results.

#### **Prior Residence**

A relatively small amount of Loudoun Residents were born in Loudoun (seven percent). This is very similar to the 2002 and 2005 survey results. Ninety-three percent of residents indicated that they moved to Loudoun from somewhere else. According to the survey, the largest percentage (41 percent) moved to Loudoun County from Fairfax County. Thirty-eight percent relocated to Loudoun from areas outside of the Washington, D.C. metro region. These figures are consistent with those obtained in previous surveys.

### Reason for Locating in Loudoun

Several factors have been found to be consistently important for households when making the decision to move to Loudoun County.

Since 1995, the top two factors influencing the decision to locate in Loudoun have been location of work site and housing affordability. In 2007, 28 percent cited location of work site as the most important factor in the decision to locate in Loudoun, and 25 percent cited housing affordability as the most important factor. These responses reflect the growing importance of Loudoun's employment base as well as Loudoun's competitive housing prices. The third most popular response was the influence of family considerations, cited by 13 percent of residents. This is similar to the 2005 survey, but different from the 2002 survey when appreciation for the rural character of Loudoun was the third most popular factor cited by residents (cited by 12 percent). In 2005 and 2007, only 7 percent cited rural character as the single most important factor influencing their decision to move to Loudoun.

The greatest percentage of households indicated that location of work site was the most important location factor in both the rural (26 percent) and non-rural (29 percent) areas. The second most important factor differed among the rural and non-rural area. Housing affordability was the second most important factor cited by residents of non-rural Loudoun (28 percent), while this ranked low for rural Loudoun residents (8 percent). The second most important factor cited by residents of rural Loudoun was rural character and beauty (21 percent).

#### Retirement

The survey asked respondents if they intended to stay in Loudoun County after retiring. Thirty-five percent said yes, 34 percent said no, and 31 percent were unsure. Of those residents who said that they would not stay in Loudoun, the top reason sited for not staying in Loudoun County was affordability of housing (35 percent). Other top responses for not staying in Loudoun County after retiring included cost of living, expenses, and general affordability (ten percent), desire for warmer climate or beach (nine percent), and family-related reasons (eight percent).

## **Employment**

The survey asked respondents how many members of their household worked full-time and how many worked part-time, as well as where they worked. Of 1,531 employees among the 1,000 households surveyed, 43 percent worked in Loudoun County, which is down from 48 percent in 2005 and 44 percent in 2002. Members of households employed in Fairfax County comprised 35 percent of all workers, which is similar to 2005 (34 percent), and down slightly from 37 percent in 2002.

Of those residents working full-time, 38 percent worked in Loudoun County and 37 percent worked in Fairfax County. Of those residents working part-time, 68 percent worked in Loudoun County and 22 percent worked in Fairfax County.

Nearly 8 percent of full-time employees worked in a business based in their home, which is similar to 2005 and 2002's figures. A greater percentage of rural area residents work full-time at home compared to non-rural area residents. In 2007, 18 percent of full-time workers living in the rural area worked at home, compared to 15 percent in 2005 and 18 percent in 2002. In 2007, 10 percent of full-time workers living in the non-rural area worked at home, which is similar to 2005 (11 percent) and 2002 (9 percent).

## **Telecommuting**

Twenty-four percent of residents indicated that someone in their household telecommutes. This is up from 19 percent in 2005. Advancements in Internet and broadband technology allow people to work from home more than they did in the past, which is a key factor in the increase in telecommuting. Transportation issues are also important. Approximately half of residents who telecommute cited transportation as the biggest area of concern facing the county.

#### **Internet Access**

Almost all (92 percent) households in Loudoun have access to the Internet in their home. There was a sharp decline of dial-up usage and the sharp increase in fiber optic cable usage in 2007 compared to prior surveys. Dial-up usage declined from 28 percent in 2005 to 11 percent in 2007. Fiber optic cable was a brand new technology back in 2005, hence there was only a 3 percent usage rate, but in 2007 usage increased sharply to 26 percent. Cable broadband remained the number one means of access between 2007 and 2005, with 30 percent and 35 percent respectively. DSL also had a high percentage of users in 2007 (20 percent) and 2005 (25 percent).

### **Information Sources about County Programs and Services**

Newspapers are the most widely used means of receiving information on county programs and services. Eighty-five percent of residents indicated that they receive information on county programs and services through newspapers. This is very similar to the 2002 and 2005 survey results. The top newspapers named were the *Loudoun Times-Mirror* (43 percent),

Loudoun Easterner (30 percent), The Washington Post (29 percent), and Leesburg Today (28 percent). An additional 1.5% of residents cited Ashburn Today, a new sister publication of Leesburg Today.

After newspapers, the next top three means of receiving information are "word of mouth," Parks and Recreation Brochure, and the county website. The second most frequently cited information source was "word of mouth" (61 percent), which is a fairly large increase from past surveys. The third most frequently cited information source was the Parks and Recreation Brochure (53 percent), which is higher than 2005 yet similar to 2002. The use of the county website as a source for obtaining information increased significantly from 35 percent in 2002 and 37 percent in 2005 to 50 percent in 2007.

#### Childcare

Childcare services have been used or searched for by about 17 percent of the households living in Loudoun County. Of those households, 33 percent were very satisfied with child care options in Loudoun County, 52 percent were satisfied, and 15 percent dissatisfied. Of those who were dissatisfied with childcare options, the top reason for dissatisfaction was that it is too expensive (35 percent). Other top responses for dissatisfaction were quality of care (19 percent), unavailability for age of child (12 percent), and not convenient to home or work (12 percent).

# Section III. Usage and Satisfaction with Selected County Services and Programs

An important function of a quality government services program is measuring the level of customer satisfaction with the services provided.

Since 1992, the Loudoun County Government has measured citizen satisfaction by means of a Service Response Card system, in which customers are encouraged to complete response cards indicating their level of satisfaction with the service provided. Many individual departments and agencies have also conducted surveys of their own customers. The response card system and some of the departmental surveys have been "self-selecting," meaning that the sample of customers surveyed has not been truly random. These surveys have nonetheless been extremely useful in providing information about the quality of county services.

To supplement the information received through these methods, it is highly useful to periodically survey a random sample of households to find out how many are using certain services, and how they would rate their level of satisfaction with those services. A truly random sample provides a more accurate evaluation of the quality of county services as rated by the residents who use them.

## **Use of County Services**

For eight service categories – building and development services, fire and rescue services, mental health/mental retardation/substance abuse services (MH/MR/SAS), parks and recreation, senior services, public libraries, public schools, and the Sheriff's Office – residents were first asked if someone in their household had used the service in the last two years. If the answer was yes, they were asked additional questions about their satisfaction with that service. If they had not used the service, they skipped any additional questions regarding that service and proceeded to the next question.

Of the 1,000 surveyed households, 89 percent indicated that someone in their household had used at least one of the designated services during the last two years. The following discussion summarizes, by service type, the characteristics of the responses. For some services, such as fire and rescue, senior services and the Sheriff's Office, the number of users constituted a smaller percentage of the sample surveyed than for other services such as public libraries and public schools, which serve a broader population on a more consistent basis.

In general, satisfaction levels with county services were similar to those obtained in previous surveys. The 2001 survey did not ask residents to describe their satisfaction with any county services.

## **Building and Development Services**

Only 12 percent of households had used building and development services in the past two years. Of the households who had used building and development services, 78 percent were satisfied or very satisfied with the services they used, which is the same as in 2005 and similar to 2002 (76 percent).

#### **Fire and Rescue Services**

Eighteen percent of households had used fire and rescue services in the past two years. Of those households who used fire and rescue services, 96 percent were satisfied or very satisfied with the quality of service. This is similar to the 2005 satisfaction rate of 98 percent and the 2002 satisfaction rate of 97 percent. High satisfaction rates have been reported in all these years.

## MH/MR/SAS

Only four percent of households had used MH/MR/SAS in the past two years. Ninety percent of residents who used these services were satisfied or very satisfied. This is a decline from 93 percent in 2005, but an increase from 81 percent in 2002.

#### **Parks and Recreation Facilities**

Usage levels for parks and recreation facilities were high. Sixty-seven percent of all households had used parks and recreation facilities in the past two years. Of those households who had used parks and recreation facilities, 95 percent in 2007 and 2005 and 94 percent in 2002 were either satisfied or very satisfied. High satisfaction rates have been reported in all these years.

### **Public Libraries**

Seventy-two percent of all households had used the public libraries within the past two years. The level of usage of public library services was very high. Of those households who used the public libraries, 95 percent in 2007 and in 2005 and 97 percent in 2002 were either satisfied or very satisfied. High satisfaction rates have been reported in all these years.

#### **Public Schools**

Over 45 percent of households had used public school services within the past two years. Of those households, 92 percent of households were either satisfied or very satisfied, which is similar to 2005 (91 percent) and slight less than 2002 (95 percent).

Of households that had school aged children, 82 percent of the children attended public schools. This is a slight decrease from the 2005 rate of 84 percent. Of those children ages 5 to 13, 83 percent attended public schools, as compared to 84 percent in 2005. Of those children ages 14 to 18, 80 percent attended public schools, which is lower than the attendance rate of 84 percent in 2005.

#### **Senior Services**

Six percent of households have used senior services in the past two years. Of those households who used senior services, 84 percent were satisfied or very satisfied, which is a lower satisfaction rate than in 2005 (93 percent), but a similar rate to that of 2002 (86 percent).

#### **Sheriff's Office**

Twenty-one percent of households had used the services of the Sheriff's Office in the past two years. Of those households, 85 percent were either satisfied or very satisfied with the services they received. This is the same as in 2005. In 2002 the satisfaction rate was slightly higher at 89 percent.

# Section IV. Opinions of Loudoun Residents

A scientific telephone survey using a random sample of households is an excellent way for Loudoun County policymakers to obtain an accurate representation of the opinions and needs of residents in different parts of the county.

The following discussion summarizes responses to several questions that addressed residents' opinions regarding key elements of living in Loudoun, and important issues facing residents of Loudoun County.

## Safety in Neighborhood

Residents were first asked if they had moved to Loudoun County or if they had always lived in Loudoun. If they had moved to Loudoun County, they were asked how safe they feel in their current neighborhood compared to where they lived before moving to Loudoun County. If they had always lived in Loudoun County they were asked how safe they feel in their neighborhood.

Ninety-three percent of residents had moved to Loudoun County from somewhere else. Of those residents, 56 percent felt very safe and 41 percent felt safe in their neighborhoods compared to where they lived before moving to Loudoun County. Results differed for the rural and non-rural areas. Seventy-one percent of rural residents felt very safe and 28 percent felt safe, with only one percent feeling unsafe compared to where they lived before Loudoun County. No residents in the rural area reported feeling very unsafe compared to where they lived before. In the non-rural area, 51 percent of residents felt very safe and 44 percent felt safe, with five percent feeling unsafe or very unsafe compared to their last place of residence. Only one resident in the non-rural area reported feeling very unsafe compared to their previous place of residence. These results are consistent with past surveys.

Seven percent of residents have always lived in Loudoun County. Of those lifelong residents, 49 percent felt very safe and 45 percent felt safe in the neighborhood they live in. The lifelong residents of rural and non-rural areas differed in their responses. Of those living in the rural area, 64 percent felt very safe and 33 percent felt safe, with only one percent feeling unsafe in their neighborhood. No residents in the rural area felt very unsafe. In the non-rural area, 42 percent of residents felt very safe and 49 percent felt safe, with four percent feeling unsafe or very unsafe in the neighborhood they live in. Only one lifelong resident in the non-rural area felt very unsafe. These results are fairly consistent with past surveys.

## **Overall Quality of Life**

The overall quality of life in Loudoun County is "good" or "excellent" according to 92 percent of residents. This is the same as 2005 (92 percent) and down from 2002 (95 percent). Rural and non-rural residents had very similar responses.

#### Value for the Tax Dollar

The belief that Loudoun County provides good value for the tax dollar was reported by seventy-five percent of residents. This is down from 78 percent in 2005 and 83 percent in 2002.

Sixty-one percent of rural area residents felt they received good value for their tax dollar, compared with 78 percent from non-rural Loudoun. The trend has been downward since 2002 for both the rural area and non-rural area, with the rural area's satisfaction declining at approximately twice that of the non-rural areas decline. In 2002, 73 percent of rural area residents and 85 percent of non-rural areas felt they received good value for their tax dollar.

## **Biggest Problem Facing Loudoun**

The biggest problem facing Loudoun was predominantly oriented toward issues of growth, development and transportation. In 2007, transportation issues (47 percent) were cited as the greatest problem in Loudoun and growth and development (40 percent) was the second greatest problem. In 2002 (47 percent) and 2005 (50 percent), growth and development was cited as the greatest problem in Loudoun County. Transportation was the second greatest problem in 2005 (44 percent) and 2002 (29 percent). In 2007, 10 percent of residents cited taxes being the single biggest issue. No other responses exceeded ten percent in 2007. In 2005 and 2002 only transportation and growth were cited by more than ten percent of residents.

## **Best Thing about Loudoun**

Loudoun's location and proximity to shopping, activities, jobs, and other amenities was the single best thing reported in both 2007 (22 percent) and 2005 (25 percent), while in 2002 (16 percent) this had the second greatest response rate. The second highest response in 2007 for the single best thing in Loudoun County was the rural countryside and open space, (20 percent) and 2005 (22 percent). In 2002, this had been the number one response, with 29 percent. Other positive attributes of Loudoun County, as indicated in the survey, included neighborhood/community (17 percent), schools (11 percent), people and friendliness (ten percent), and beauty/scenery (ten percent).

#### **Nighttime Activities**

Residents were asked if Loudoun had a sufficient amount of nighttime activities for members of their household. Sixty percent of residents said that Loudoun County had a sufficient amount of nighttime activities, 27 percent said that it did not, and the other 13 percent were unsure

Residents were asked what nighttime activities were missing from Loudoun County. More than one response was accepted from respondents. The greatest missing nighttime activity cited by residents was live theatre, such as plays and musicals (36 percent). The next greatest response was live entertainment and music (30 percent). Other high responses were downtown events such as art galleries, concerts, and special events (27 percent), bars and nightclubs (27 percent), movie theatres (26 percent), fine dining (25 percent), sporting events (22 percent), and symphony or orchestra (22 percent).

## Section V. Conclusions

As with the previous Loudoun County surveys, the 2007 survey develops a demographic profile of Loudoun households and provides updated information about opinions of Loudoun residents. Though the profile is diversifying, opinions from previous surveys are generally consistent with the 2007 findings.

One recurring theme in Loudoun County is concern about growth and transportation issues. Traffic and transportation problems have surpassed growth as being the biggest problem that residents are facing. Growth is now the second biggest problem facing Loudoun County.

Survey results reflect residents' perception of the County's high quality of life. In 2007 and in prior surveys, residents have given high ratings to the public school system, location and proximity to amenities and jobs, neighborhoods, friendliness, safety, and rural beauty. This perception of a high quality of life has become more pronounced in 2007 than in 2002 and 2005.

Respondents expressed mixed opinions regarding housing affordability. While affordability is the second most frequently (by 25 percent) cited reason for moving to the county, it is identified by others as a reason for potentially leaving the county. Thirty-five percent of the residents who plan to leave the county upon retirement or who are unsure as to whether they will leave the county (31 percent of respondents) cited housing affordability as the main reason for potentially leaving.

The decisions of older residents to stay or leave the county can have significant service delivery and tax implications, as many homeowners over the age of 65 are taxed at lower rates. The demographic profile of the households that replace those that leave could have significant service delivery and tax implications depending on the age of the household residents and the presence of school age children.

As racial and ethnic diversity increases in Loudoun County, disseminating important information about county programs and services to residents will be increasingly challenging. Language and culture barriers will have to be overcome by the county government in order to adequately serve all of the residents of Loudoun.

As Loudoun County continues to attract residents with high expectations for their families, living environment and local amenities, the county will continue to be challenged to meet the needs and desires of all its residents.

#### Appendix F Methodology

#### **2007 Survey of Loudoun County Residents**

The 2007 Survey of Loudoun Residents was designed to be a telephone survey, approximately five to ten minutes in duration. A marketing research firm, Decision Data Collection, Inc., was retained to conduct the telephone survey of Loudoun households.

The survey instrument, modeled on previous Loudoun County surveys, was modified slightly to reflect current information needs and was further reviewed by Decision Data Collection's statistical experts.

Decision Data Collection was able to achieve a fairly high cooperation level of 63.7 percent from Loudoun residents. In 2005 the cooperation level was 76.5 percent and 69.8 percent in 2002. This indicates a relatively strong willingness on the part of Loudoun County citizens to communicate with the county government and Board of Supervisors about important issues.

A Spanish language survey option was available for those who requested it. Nine people (0.9% of all respondents) requested and completed the survey in Spanish.

#### Geography

As in prior surveys, the geographic areas that the county is divided into are based on an aggregation of zip codes. Groupings of zip codes are preferred because virtually all respondents know which zip code they live in and virtually all are willing to give their zip code during the interviewing process.

The county was divided into two areas, rural and non-rural, for the 2007 survey. In past surveys, the county was divided into three areas -- east, central, and west. The large population growth that the county has experienced over the past several years has changed the demographics of the county and created a westward expansion of the population. The population growth in the central and eastern area have caused these two areas to merge together geographically and demographically, so these areas are now represented as one area, the non-rural area. In prior surveys, the Aldie (20105) and Arcola (20107) zip codes were part of the western area. Aldie has had a large amount of population growth east of Route 15 and the majority of that zip code's population is now east of Route 15. All zip codes that are completely east of Route 15 or have portions east of Route 15 are included in the non-rural area. Therefore, the Aldie and Arcola zip codes are now part of the non-rural area.

Another change made in 2007 with respect to zip codes pertained to PO Box zip codes. PO Box zip codes were included in prior surveys, but not in the 2007 survey. PO Box zip codes

do not have a geographic area associated with them and residents with PO Box zip codes do not necessarily live in the area surrounding the post office where the PO Box is held. Therefore, the decision was made to remove PO Box zip codes from the 2007 survey. For the 2002 and 2005 surveys the assumption was made that residents holding a PO Box zip code lived in the area surrounding the post office where the PO Box was held.

Three additional zip codes were added to the 2007 survey. Those three zip codes were 20120, 20151, and 20170.

The following two tables list the zip codes in Loudoun County. To afford the opportunity to analyze changes over time for a few specific variables, 2002 and 2005 results were adjusted using the same geographies used for the 2007 survey. The first table (Table D-1) lists the non-rural area zip codes using the non-rural area definition defined in the 2007 survey, and it lists whether or not the zip code was included in a particular year's survey results. The second table (Table D-2) lists the rural area zip codes as defined for the 2007 survey, and it lists whether or not the zip code was included in a particular year's survey results.

#### **Sample Size and Sample Error**

The survey solicited responses from a stratified random sample of 250 households in the rural areas and 750 households in non-rural areas, totaling 1,000 Loudoun County residents overall. There were an estimated 95,666 households in Loudoun County in 2007. The survey sample represents slightly more than 1 percent of all households in Loudoun County. The rural area of the county has a relatively small number of households. There are 13,219 households in the rural area, which is 13.8% of the county's households. As in prior surveys, the rural area was over-sampled in order to provide more statistically reliable results and a more detailed look at the demographics and opinions of the residents of that area of the county. Countywide, the data is within +/- 3.1 percent at the 95 percent confidence level. The rural area's data is within +/- 6.1 percent at the 95 percent confidence level. The non-rural area's data is within +/- 3.6 percent at the 95 percent confidence level.

#### Weighting

Geographic weighting was used beginning with the 2007 survey to generalize results to the entire county and within the rural and non-rural areas so that one zip code's population was not over- or under-represented. The data was weighted to reflect the population of each zip code. To afford the opportunity to analyze changes over time for a few specific variables, 2002 and

2005 results were adjusted using the same statistical methods and geographies used for the 2007 survey. The following tables detail the population, sample, and weights applied to the 2002, 2005, and 2007 county, rural, and non-rural data.
