## **Craft Vendor Information**

The Lanesville Heritage Area of Claude Moore Park will be center stage for the Fall Festival. Vendors of hand-made crafts will sell their wares near the 1779 Ordinary and 1870 Schoolhouse. The Festival is family oriented, featuring activities, crafts, a photo expo, musical entertainment, and more. The park is about 30 miles from both Washington DC & Frederick, MD, near the intersections of Virginia's Routes 7 & 28.

#### **Show Information & Requirements**

- Outdoor show takes place rain or shine; severe weather will cancel.
- Show is open to crafters with <u>hand-made</u> items created in the United States; manufacturers, resellers, importers and retailers will not be accepted.
- The \$25.00 fee is for a 10' x 10' booth space; vendors must provide their own tables, chairs, and tents.
- Limited electricity is available for a \$10 fee. Inquire for availability.
- We reserve the right to limit the number of vendors in each craft category; apply early.
- A confirmation letter and receipt will be sent when a vendor is accepted.
- An information packet (directions, parking, booth location, etc.) will be sent one week from the event.
- All vendors are responsible for collecting and reporting Virginia Sales tax.
- Vendors may drop off materials at their booths then park cars in designated spaces.
- Vendors must set up by 9:30 AM and remain through the end of the show at 3:00PM.
- Public admission to the Fall Festival will be FREE.
- Food vendor spaces are available; Inquire about fee. See Health Department permit information below.

#### **Application Requirements**

- Completed application, booth fee, and two or more photos must be submitted.
  - \* One photo of crafter making items
  - \* One or more photo of finished products for sale
  - \* Photos must be 4 x 6" or larger and will not be returned
  - \* Digital photos may be submitted to <a href="mailto:claudemoore@loudoun.gov">claudemoore@loudoun.gov</a>
- Vendors of food products who want to sample/sell must meet all Commonwealth of Virginia Health
  Department guidelines. Vendor must have a permit or meet temporary food service guidelines which
  require a Temporary Food Permit Application and \$25.00 fee to be submitted to Claude Moore Park,
  prior to August 23, 2024.

#### **Cancellation Policy**

- Cancellations will be considered on a case-by-case basis.
- If extreme circumstances require Claude Moore Park to cancel the Festival, refunds will be issued.
