- b. W-9

Answer 5. The items listed on the pricing pages are relevant to the Prime only.

Question 6. Proposal Item G Key Staff Availability and Project Management asks for primary work location of all team members and then asks for the same for representatives providing construction administration. Please clarify: does construction administration refer to design support during construction or are you asking for construction inspection services during construction? Design support would be provided by the team members noted in the first bullet and if we are to provide construction inspection, should that firm be a member of the team?

Answer 6. Construction Administration refers to design support during construction, not construction inspection services.
