The following changes and/or additions shall be made to the original Request for Proposal (RFP) for Agenda Management System, RFQ 99780. Please acknowledge receipt of this addendum by signing and returning <u>with your proposal</u>.

- 1. Please note the Acceptance Date has been changed to prior to 4:00 p.m., September 23, 2019 "Atomic" Time.
- 2. Section 5.8 of the RFP has been deleted in its entirety.
- 3. Section 5.12 of the RFP has been deleted in its entirety and replaced with the following:
 - 5.12 System Warranty and Ongoing Maintenance Support
 - A. The Contractor shall provide a fixed cost for maintenance fees for years one (1) through five (5) as provided in the pricing proposal herein. In addition, the Contractor shall provide a fixed percentage for increases, but in no case shall any increase in any given year exceed ten (10) percent from the previous year's maintenance fees.
 - B. It is required that any selected Contractor maintain compliance with all State and Federal mandates, updates, and modifications related to the New System as part of the support they provide.
- 4. Section 10.0 of the RFP has been deleted in its entirety and replaced with the attached Proposal Submission Forms Revised.
- 5. Attached are the questions and answers received in response to the solicitation.
