# The WHY of applying for Grants: Rethinking "free money"

"For funders, a grant award is an investment in positive change. It's a tool they use for having an impact on issues they care about.

...[N]onprofits must consider grants from a mission-focused perspective. Since the point of a grant award is impact rather than money, the real point of a grant proposal is to rally the necessary resources to help the nonprofit fulfill its purpose...to address important issues within their communities.

A grant proposal is actually a **call to action**. It's a request that a funder join the nonprofit as a partner in achieving specific results. At its best, a grant proposal is a cogent, persuasive, well-supported argument for change."

## FY 2021 Application changes

Bonus points will not be added on to the final scores.

Each question will include word limit suggestions.

The application evaluation requirements will be shared in application materials.

The evaluation plan will include required outcomes.

## FY 2021 Application Changes

Questions will be answered via web portal to ensure equity to respondents.

As in previous years, no organization may request more than 30% of its current operating revenue.

➤ Individual awards will be limited to no more than \$113,000.

## Constant across years

### Eligibility criteria

- 501c3 nonprofit certified by Internal Revenue Service at time of application
- Mission consistent with the County's overall mission
- Existing funding from other sources
- Certificate of Good Standing from the State Corporation Commission

- Additional criteria in Grant Manual

## **Application Scoring**

Commonwealth's Best Value rating method. A scale of 0-3 will be used.

3=Excellent: Response demonstrates a very strong fit with the objectives of the question.

2= Acceptable: Response demonstrates an adequate fit with the objectives of the question.

1= Unacceptable: Response fails to demonstrate a reasonable fit with the objectives of the question.

0= Deficient: Response fails to demonstrate relationship to objectives of the question or is deemed unresponsive to the question.

## Funding

- Review team will develop recommendations for funding based on scores
- Final approved funding amount based on
  - Available funding
  - Volume of requests
  - Application score
  - Reasonability of proposed budget items and cost for services
  - Ratio of County funding to the organization's overall operating revenues (no more than 30%)

## Funding

- The Board of Supervisors has sliding award amount to be applied to full applications meeting the minimum score, with a proportion of the requested amount to be awarded based on the application score.
- For mini-grants, organizations will be awarded the full amounts they request.

### **Awards**

- Funding awards will be announced publicly at the second April Board of Supervisors meeting
- All applicants will be notified of their status within one week after this meeting
- Funding begins on July 1, 2020 and expires on June 30, 2021

### Why evaluate programs?

- Supports program and strategic planning
- Helps communicate your story
- Tracks progress toward goals
- Serves as basis for ongoing learning to make work stronger and more effective

### Evaluation

- •What do you expect to result from the program? SMART objectives: specific, measurable, achievable, realistic, and time-bound
- If you have defined the problem well, the outcomes will follow logically (if...then...)
- Think about what outcomes your program prevents, e.g. cost for other services, short and long term. If possible, calculate savings.

How many tools or resources will be provided to individuals, families, or orgs by June 30 2021?(output)	One class on preventing binge drinking
How often will services be provided? (output)	Weekly from 10/2020 through 12/2020
How many contacts or service responses, on average, will you have with each individual, family, or org by June 30 2021? (output)	12 one-hour classes

## Example, continued

What number (or percentage) of these contacts do you anticipate will result in a decreased need for services? (if applicable) (outcome)

Based on research, we anticipate 90% will not need additional services for binge drinking in the next year.

What impact(s) will these services and resources have on the quality of life for individuals, families and orgs by June 30 2021? (outcome)

- 1. 90% (180) of participants will report new skills in avoiding peer pressure to drink
- 2. 80% (160) of participants will report they did not engage in binge drinking during the past 3 months

What data sources will help you determine if you made an impact?

- 1. Survey of participants at last class
- 2. Survey of participants 3 months after last class

### **SMART Outcomes**

#### Specific

- Includes "who," "what," and "where"
- Use only one action verb to avoid issues with measuring success (we will prevent AND intervene...)

#### Measurable

Focuses on "how much" change is expected

#### Aggressive but Attainable

- Realistic given resources and planned implementation
- May be based on previous performance

#### **Results Oriented**

Directly relates to program goals

#### Time-bound

## Example

### Output:

We will train 30 employees in CPR

### Outcome:

 90% of employees receiving CPR training will show a gain in knowledge of life-saving techniques, as indicated by pre and post tests

### Outcome Scope

Realistic boundaries based on program's reach

 Residents of Loudoun County; students attending Tuscarora High School

Age

oyouth ages 8-12; children grades K-6

Income level or financial circumstance olow-income; middle class with bad credit

Ethnicity or culture

opredominantly Latino; recent immigrants

Other characteristics of participants

opart-time worker; survivor of abuse

### **Outcome Measures**

What type of data will you collect to show that you are meeting your outcomes?

- Number
- Percentage

### Linking Outcomes to Operational Requests

Challenge: Determining outcomes when requesting operational support

What kind of outcomes come from paying the rent or salaries?

Solution: Look at "If... then..." scenarios

Rent Example: If we do not have rent money, then we will not have adequate space for our program, and we would be unable to increase the GPAs of 50 teens

Outcome: 50 teens will increase their GPAs through our afterschool program

Salary Example: If we are unable to pay staff a competitive salary, then we will not be able to retain high quality certified staff to lead programs.

Outcome: 5 programs rated as "high quality" led by certified staff will be provided to community members
