2021 Seasonal Water Recreational Facility Opening Guide

Special Note: Under the Fitness and Exercise Facilities Section of Governor Northam's Third Amended Executive Order 72. Hot tubs, spas, splash pads, spray pools, and interactive play features, except water slides, must remain closed and swimming pools may be open, provided occupancy is limited to no more than 75 percent of the lowest occupancy load on the certificate of occupancy and all swimmers maintain at least 10 feet of physical distance from others who are not Family members. This Order shall remain in full force and effect until amended or rescinded by further executive order.

A 2021 Permit is required for ALL Seasonal Pools before opening to the public

1. Print this 2021 Opening Guide.
Submit Application and Fee for each pool (submit together)
\$220 for seasonal pool check payable County of Loudoun.
2. Schedule inspection with assigned EHS (see attached list).
All Pools will receive a Pre-Opening Inspection (in person or virtual) to obtain a permit.
Mandatory items are to be completed BEFORE scheduling pre-open inspection.

Below are the mandatory items that need to be complete and operational before and at time of the Health Department Pre-Open Inspection: *

Complete for ALL pools – main pool, wading, spa, other

- a. Main Drain cover visible and correctly secured with all required screws in place.
- b. Return flow is balanced with all returns functional and Passes Dye Test.
- c. Perimeter fence is in good condition.
- d. Recirculation system meets required minimum turnover.
- e. Flow meters are operating properly, are legible and in good repair.
- f. An accurate placard is posted in the filter room.
- g. Chlorination system is operating correctly, all components properly installed and in good condition (lines, squeeze tubes, fittings & injectors).
- h. All outstanding Issues from 2019 and 2020 inspections or compliance letters have been addressed.

*Note: Other items on the "Swimming Pool Inspection Guide" must be satisfactorily addressed to obtain a permit to open and operate. If any item is not adequately addressed then a permit will not be issued and a re-inspection required.
